

COOPERATION AGREEMENT

between

University of Kragujevac Faculty of Education, located at Milana Mijalkovića 14, 35000 Jagodina, Republik of Serbia, represented by the Dean prof. dr Nenad Vulović

and

Jan Kochanowski University of Kielce, located at Żeromskiego 5, 25-369 Kielce, Poland, represented by the Rector prof. dr hab. Beata Wojciechowska.

§ 1

University of Kragujevac – Faculty of Education and the Jan Kochanowski University of Kielce hereinafter referred to as the „Parties” have decided to conclude a cooperation agreement for the purpose of education, conducting scientific research and developing academic relationships between students, doctoral students and staff of both institutions.

§ 2

The cooperation between the Parties may include:

- 1) joint research and education projects,
- 2) joint cultural programmes,
- 3) creating joint study programmes and courses,
- 4) exchange of students, doctoral students and staff,
- 5) exchange of information, teaching and research materials and scientific publications,
- 6) guest lectures, seminars, study visits,
- 7) co-organising conferences and symposia,
- 8) promoting educational activities,
- 9) other initiatives agreed upon by both Parties.

§ 3

1. Detailed terms and conditions for the implementation of activities undertaken in cooperation between the Parties may be specified in separate agreements.
2. The Parties agree to undertake necessary steps and to provide mutual support in order to ensure funds for the implementation of the agreement.
3. Financing of activities under the agreement shall take place on a reciprocal basis in accordance with financial capabilities of the Parties.

4. The agreement imposes no financial obligations on either Party. Financial matters shall be addressed in separate arrangements adopted by the Parties.
5. The agreement will be executed in compliance with the laws of both countries.

§ 5

1. The agreement is concluded for the period of 5 years and thereafter automatically renewed for consecutive periods of 5 years.
2. Either Party may terminate the agreement with a 3-month notice period.
3. Any changes to the content of the agreement shall require a written annex and shall be binding when signed by both Parties.
4. The agreement in each language version has been drawn up in two copies. The Parties receive one copy in either language.
5. The agreement shall become effective on the date it is signed by a Party signing it later.
